Abstract submissions must be received on or before February 15, 2017 Authors of accepted papers will be notified approximately March 20, 2017 Registration for presenters must be completed and paid by April 30, 2017 Full papers are encouraged to be uploaded to Conference Maker by May 31, 2017

Pre-Conference Workshops:

Several pre-conference workshops will be scheduled prior to the opening of the conference on Monday and Tuesday, June 26 and 27. Details about workshops will be posted on the conference website in due course.

Student Prizes:
